OpenShift Container Platform (OCP) is a platform for developing and running containerized applications. It is designed to allow applications and the data centers that support them to expand from just a few machines and applications to thousands of machines that serve millions of clients.

OpenShift Container Platform incorporates Kubernetes open source technology, the defacto standard for orchestrating containers. Red Hat technologies allow deployments ranging from a single cloud to on-premise and multi-cloud environments. The container images and the containers that run from them are the primary building blocks for modern application development, and OCP allows users to manage building application containers, provide reliable and flexible distribution systems, deployment of these containers, monitoring the applications, management of their lifecycle, and connections to other storage, networking, or host resources.
